ENDORSEMENT OF JUSTICE J. DIETRICH:

[1] A date for a motion by the Receiver to approve a proposed sale process, including approval of a stalking horse credit bid offer (for the purpose of serving as a stalking horse bid) submitted by Home Trust Company ("HTC"), was scheduled for August 15, 2025 for 90 minutes pursuant to an endorsement of Justice Kimmel.

[2] Subsequently, counsel for the Receiver learned that it had inadvertently not served the correct counsel for the Respondents, who contacted the Receiver later in the day on July 23, 2025. Respondents' counsel has requested a new date and timetable as they are not available on August 15, 2025.

[3] The time on August 15, 2025 is hereby vacated and the motion is scheduled to be heard in accordance with the following schedule:

- a. Receiver's motion record to be delivered on or before August 8, 2025;
- b. Any written questions to be submitted to the Receiver on or before August 13, 2025;
- c. Receiver to provide written responses to questions on or before August 20, 2025;
- d. Responding material to be delivered on or before August 29, 2025;
- e. Reply evidence, if any and Factum of the Receiver to be delivered on or before September 2, 2025;
- f. Responding factum to be delivered on or before September 5, 2025;
- g. Reply Factum (if any) to be delivered on or before September 9, 2025;
- h. Hearing **for 90 minutes (virtual) on September 11, 2025 at 11:00 am.**

[4] All material is to be uploaded to case center no later than September 5, 2025 with the reply factum to follow as necessary.

[5] The Respondent's counsel has advised he is travelling at the time of the scheduled hearing, but in order to accommodate the schedule will make himself available. In the circumstances, Respondent's counsel is not required to gown.
