Hooper sworn the 26th day of November, 2019, the Affidavit of Service of Kyle Plunkett sworn the 2nd day of January, 2020, the Consent of RSM Canada Limited ("RSM") to act as trustee of the property of Ontario HVAC & Water Inc. (the "Debtor"), and upon hearing submissions of counsel for One Dealer and the Debtor and it appearing to the Court that the following act of bankruptcy has been committed:

- (a) that the Debtor ceased to meet its liabilities generally as they became due, in that it has failed to pay its obligations to the applicant creditor One Dealer.
- 1. **THIS COURT ORDERS** that the Debtor be adjudged bankrupt, and a bankruptcy order is hereby made against the Debtor on this date.
