Thank you for these documents. Among the many problems we have with these documents, The Peoples Trust Company Term Sheet is not a commitment to provide any financing and is subject to your client forming a JV with Geranium to build out the King Road property. The proposed amount of the financing is insufficient to payout all encumbrances, including the fees and expenses of the receiver. The alternative financing term sheet from Benson Capital and the commitment from Kyko Global are also non-binding and do not generate sufficient funds to payout all encumbrances, including the receiver's fees and expenses.

In addition, a refinancing is inconsistent with the purported sale of the property by your client. We previously asked counsel for the purchaser to advise who prepared the APS and provide proof of payment of the deposit. We have yet to receive this information and so make the same request of you as counsel for the Debtor.

Option 1

- 1. A Term Sheet has been signed with People's Trust Company. It is attached. The financing was arranged through Jonah Brown at Oakbank Mortgage Brokers. My client has paid the requisite fees. Copy enclosed;
- 2. Oakbank has confirmed that People's has accepted the borrowers' covenant(s), the current planning status for the property and its appraisal;
