- (iv) discharging the Receiver upon the filing of the Receiver's Discharge

  Certificate (as defined in the First Report) and releasing TDB from

  any and all liability, as set out in this Order,

was heard this day at 330 University Avenue, Toronto, Ontario.

ON READING the First Report, the fee affidavit appended thereto of Jeffery Berger affirmed June 26,2025 (the "**Fee Affidavit**"), and on hearing the submissions of counsel for the Receiver and the parties listed on the counsel slip, no one else appearing although served;

#### A. Activities, Fees and Disbursements

2. THIS COURT ORDERS that the activities of the Receiver, as set out in the First Report, are hereby approved, provided, however, that only the Receiver, in its personal capacity and only with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approval.

- 3. THIS COURT ORDERS that the fees and disbursements of the Receiver, as set out in the Fee Affidavit, including the estimated further fees of the Receiver, are hereby approved.
- 4. THIS COURT ORDERS that the R&D is hereby approved.

#### B. Discharge

- 5. THIS COURT ORDERS that upon the Receiver filing a certificate substantially in the form attached hereto as Schedule "A" certifying that the Remaining Activities have been completed (the "Discharge Condition"), the Receiver shall be discharged as Receiver of the undertaking, property and assets of the Debtors, provided however that notwithstanding its discharge herein the Receiver shall continue to have the benefit of the provisions of all Orders made in this proceeding, including all approvals, protections and stays of proceedings in favour of TDB in its capacity as Receiver.
- 6. THIS COURT ORDERS AND DECLARES that TDB is hereby released and discharged from any and all liability that TDB now has or may hereafter have by reason of, or in any way arising out of, the acts or omissions of TDB while acting in its capacity as Receiver herein, save and except for any gross negligence or wilful misconduct on the Receiver's part. Without limiting the generality of the foregoing, TDB is hereby forever released and discharged from any and all liability relating to matters that were raised, or which could have been raised, in the within receivership proceedings, save and except for any gross negligence or wilful misconduct on the Receiver's part.
