ON READING the Motion Record of Grenville dated January 10, 2017, filed, including the Affidavit of Donnacha Rahill sworn January 10, 2017, and on reading the First Report to Court of the Proposal Trustee, Collins Barrow Toronto Limited ("**CBTL**"), dated December 20, 2016, and the Report to Court of the Proposal Trustee dated December 29, 2016, and

ON HEARING the submissions of counsel for Grenville, counsel for CBTL, counsel for Debtor and counsel for Platinum Investment Group Inc. ("Platinum");

- 1. **THIS COURT ORDERS** that the First Report of the Proposal Trustee dated December 20, 2016 and the Report of the Proposal Trustee dated December 29, 2016 are hereby approved and the actions of the Proposal Trustee described therein are hereby approved.
- 2. **THIS COURT ORDERS AND DECLARES** that, pursuant to subsection 50.4(11) of the BIA, the Proposal Period is hereby terminated.
- 3. **THIS COURT ORDERS** that, pursuant to sections 14.04 and 57.1 of the BIA, Farber is hereby appointed as the Debtor's bankruptcy trustee.
- 4. **THIS COURT ORDERS** that CBTL is hereby discharged as the Proposal Trustee, provided however that notwithstanding its discharge herein, CBTL shall continue to have the benefit of all the rights and protections afforded to the Proposal Trustee under the BIA or as an officer of this Court.

- 5. THIS COURT ORDERS AND DECLARES that CBTL is hereby released and discharged from any and all liability that CBTL now has or may hereafter have by reason of, or in any way arising out of, the acts or omissions of CBTL while acting in its capacity as the Proposal Trustee, save and except for any gross negligence or wilful misconduct on the Proposal Trustee's part. Without limiting the generality of the foregoing, CBTL is hereby forever released and discharged from any and all liability relating to matters that were raised, or which could have been raised, in the within proceedings, save and except for any gross negligence or wilful misconduct on the Proposal Trustee's part.
- 6. **THIS COURT ORDERS** that the fees and disbursements of the Proposal Trustee and its counsel be and are hereby approved, provided that such fees and disbursements: (i) do not exceed \$50,000 in the aggregate; and (ii) are not paid from the Debtor's estate.
