**Re: In the Matter of the Proposal of Patisserie Monaco Inc.**

On November 6, 2014 (the "Filing Date"), Patisserie Monaco Inc. ("PMI") filed with the Office of the Superintendent of Bankruptcy a Notice of Intention to Make a Proposal (the "NOI") and Collins Barrow Toronto Limited consented to act as proposal trustee (the "Trustee"). A copy of the NOI is attached hereto along with a list of PMI's creditors.

Under the provisions of the *Bankruptcy and Insolvency Act*, PMI is granted an automatic stay of proceedings for 30 days from the Filing Date (the "Stay Period") and no creditor has any remedy against the insolvent person or the insolvent person's property, or shall commence or continue any action, execution or other proceedings for the recovery of a claim provable in bankruptcy.

At this time, PMI is working collaboratively with the Trustee to prepare a proposal to all creditors and is required to file same within 30 days unless the Stay Period is extended by the Court.

Once the proposal has been filed with the Official Receiver, a meeting of creditors will be called and additional information will be provided to you at that time.
