The receiver gives notice and declares that:

- 1. On the 22nd day of April, 2024, the undersigned TDB Restructuring Limited was appointed as receiver (the "**Receiver**") without security, over the lands and premises legally described as PCL 243-1 SEC 40M1677; BLK 243 PL 40M1677; Town of Ajax, (the "**Real Property**"). The Receiver understands that the Real Property is vacant land, located at the south-east corner of the intersection of Rossland Rd. W and Harkins Drive in Ajax, Ontario.
- 2. The undersigned became a receiver in respect of the Real Property by virtue of being appointed by the Ontario Superior Court of Justice Commercial List.
- 3. The undersigned commenced the exercise of its powers in respect of that appointment on the 22^{nd} day of April, 2024.
