- 2. **THIS COURT ORDERS** the Respondent's current former and past directors, officers, shareholders and any other Person, as such term is defined in the Order of the Honourable Mr. Justice W.D. Black appointing the Receiver dated June 14, 2024 (the "Receivership Order") to forthwith comply with the Receiver's information requests described in the First Report and to comply with paragraphs 3,4 and 5 of the Receivership Order by, *inter alia*, granting the Receiver immediate and continued access to the Property (as defined in the Receivership Order) and delivering all Property to the Receiver upon the Receiver's request.
- 3. **THIS COURT ORDERS** that Confidential Appendix "1" to the First report shall be sealed and kept confidential and not form part of the public record, until the completion of the closing of a sale transaction following the Sale Process or further order of the Court.
- 4. **THIS COURT ORDERS** that this Order and all of its provisions are effective as of 12:01 a.m. (Eastern Time) on the date of this Order without the need for entry or filing.
