NOTICE OF VIRTUAL HEARING ON FIRST DAY MOTIONS

The deadline to register for remote attendance at first-day hearings is **one-hour prior to the hearing** unless otherwise noticed. In the absence of extenuating circumstances, chambers typically will not provide Zoom links to those

who fail to register by the deadline. Please refer to the Court's website for further information and requirements.
